As a dean of the Graduate School of Finance (GSF) at Pusan National University (PNU), I would like to warmly invite one or two promising student(s) in your university to our graduate program. Pusan is the most beautiful coastal city in Korea. Pusan National University is a premier national university in Korea. We will launch our GSF in September 2018 with financial support from Korean government (Financial Services Commission) and Pusan Metropolitan City. To be a graduate student of PNU GSF, proficiency in English is required. Proficiency in Korean (level 3 or higher in TOPIK) is preferred.
